APRIL 17, 2013

This issue is an index of the bills we have reported to date in Legislative Report and the status of those bills as of April 12, the Committee passage deadline for non-exempt bills in the house of origin. The next deadline for bills is April 23, when they must be out of their house of origin.

Please Note:

Bills may qualify as “exempt” from deadlines because they are: (1) appropriation bills, (2) tax or fee bills, or (3) bills with a fiscal impact. In almost all of these cases those bills will be referred to the money committee of the house of origin (Assembly Ways and Means or Senate Finance). They will be acted upon at such time as sufficient revenue information is available. Other bills which do not follow the deadline rules include study committees, Constitutional amendments and bills dealing with Legislative issues.

This index will be updated following the next Legislative deadline, which is April 23 at which time all bills that are not exempt must be out of the house of origin.
